This information notice governs the processing of personal data by our company within this website, in compliance with regulations in force on the protection of data, specifically EU Regulation 2016/679 (the "GDPR").

Privacy Policy

This page provides a description of how the website manages the processing of its users' personal data. This policy is provided pursuant to the new GDPR 2016/679 on the protection of personal data for anyone interacting with the web services that can be accessed on the Internet from the address: https://www.2g-r.it/.

This policy only applies to this website and not to any other websites that users may visit via links. The information provided below regards in particular the collection of personal data online, identifying the minimum measures that must be implemented with respect to the data subjects to guarantee the fairness and lawfulness of such practices.

Location of the data processing

The processing connected to the web services of this website shall take place at the aforementioned registered office. This processing shall only be handled by employees, contractors or people appointed to process data or by any staff tasked with occasional maintenance operations. No data from the web service is disclosed or circulated. The personal data provided by users who submit requests for information are only used to perform the requested service and are only sent to third parties if it is necessary for this purpose.

Data, purposes and legal grounds

The computer systems and programs used to run this website might acquire certain personal data, which are transmitted using Internet communication protocols (e.g. the IP addresses or domain names of computers used by users who visit the website, the URI addresses – Uniform Resource Identifier – of the requested resources, the time of the request, the method used to submit the request to the server, the size of the file received in reply, the numerical code indicating the status of the reply from the server – successful, error, etc. – and other parameters relating to the user's operating system and computer set-up). Although this information is not collected to be associated with identified data subjects, by its very nature it might be used to identify users by means of processing and matching with data held by third parties.

We use this type of data only to extract statistical information not associated with any identifying data of the user on website use as well as to ensure it is operating properly. They are erased immediately after being processed. The data could be used to ascertain liability in the event of possible crimes against the website.

If your personal data (name, surname, email address, personal information, bank details) are sent explicitly and voluntarily to the address indicated on this website or by completing the form to request an estimate or for more information about our business, the sender's email address will then be stored together with any other personal data in the message in order to reply to the request or query.

Newsletters and processing of your data

If you have consented to receiving commercial communications by ticking the relevant box, your data may be processed to send direct marketing communications, newsletters or advertising materials, or to perform market research by means of traditional contact systems and automated computer systems, including commercial or promotional communications by email or text message. This constitutes the consent of the data subject expressed in accordance with this policy. In this case, consent to the processing of personal data is not a contractual obligation. The data subject has the right to provide their personal data. However, in the event of failure to provide such data it will not be possible to carry out any marketing activities. The Data Controller notes that it is possible to object to the processing of personal data for marketing purposes only partially, for example only opposing the sending of promotional communications via automated and/or digital means, or alternatively via traditional methods.

Processing methods

Personal data are processed with automated means for the time strictly necessary to achieve the purposes for which they were collected, unless this information is subject to other processing by the Data Controller. Specific security measures are implemented to prevent data loss and unlawful or inappropriate use in accordance with the obligations on minimum security measures.

In any case, if you withdraw your consent, your data shall no longer be processed.

Please also note that you may exercise the following rights with the Data Controller:

Right to request access to your personal data (Article 15).

Right to amend (Article 16) or delete personal data (Article 17). Right to restrict (Article 18) or object to processing (Article 21). Right to data portability (Article 20).

Right to withdraw consent granted for one or several specific purposes, at any time, without prejudice to any processing carried out before the withdrawal of consent (which you may request to delete).

Right to file a complaint with the Italian Data Protection Authority (Article 77).
